

Major international law firms in Singapore

Singapore has been attracting significant attention from international law firms in Asia recently. SSQ has analysed the latest Singapore Legal Services Regulatory Authority (LSRA) data from the major US/UK-headquartered international law firms' perspective. Hopefully this information will assist our clients, as well as the international legal community in general, to better assess whether and how to establish a Singapore presence, as well as how to maintain and grow any existing operations.

An overview of the law firms and lawyers in Singapore

According to the LSRA's record, there are currently 1,152* active law firms and 7,429* lawyers registered in Singapore. Following the local rules governing the legal profession and the practice of law in Singapore (the Legal Profession Act, or LPA) we categorise these as follows:


*The categorisation of law firms into "Large", "Medium" and "Small" refer to firms with (a) 1 to 5 lawyers, (b) 6 to 30 lawyers and (c) 31 or more lawyers, respectively.

*The "permitted areas of legal practice" in Singapore include banking law, corporate law, intellectual property law and maritime law but exclude domestic areas of litigation and general practice such as criminal law, family law, retail conveyancing and constitutional law.

The majority of law firms in Singapore are SLP or FLP, which, in total, accounts for 98% (1,134 out of 1,152). The other two standalone law firm entities, QFLP and JLV, are just 18 combined in number (9 for each) which represents only 2% of the market.

Furthermore, SLPs are the dominant players in the market, representing 86% of all firms (996), while FLPs share only 12% (138). There are a further 3 types of law practice in Singapore: FLA, RO and GP – but they are not recognized as standalone law firm entities and therefore cannot practice law on their own.

Shares of different types of law practices in Singapore




Only 45 of these 1,152 are large firms (more than 30 lawyers), less than 4%. These 45 firms include 24 SLPs, 8 FLPs, 8 QFLPs and 5 JLVs. It is interesting to note that there is a much larger percentage of foreign law firms (namely, FLPs, QFLPs and JLVs) being large or medium-sized than that of SLPs.


100% of QFLPs and JLVs are large/medium-sized and the large/medium-sized FLP/QFLP/JLV firms account for 42% (21+45 of 156), while SLPs of large/medium size account for only 19% (24+164 of 996) and over 80% SLPs (808 of 996) are small sized - either sole proprietorships or firms of less than 5 lawyers.

Shares of different-sized foreign law firms








Like the pattern of law firm types above, where most are either purely local SLPs or purely foreign FLPs, the majority of lawyers in Singapore are either Singapore solicitors working at SLPs, the number of which is about 5,555, representing 75% of the whole market; or foreign lawyers who practice foreign law only, the number of which is 1,265, representing 17% of the market.

Ratio of Singapore and foreign lawyers




Approximately 9% of Singapore solicitors (558 out of 6,113) are registered to practice local law but through foreign law firms (namely, FLPs, QFLPs and JLVs). Obviously, many in this group made such a choice because of the stronger network and capabilities the FLPs, QFLPs and JLVs possess when compared to the SLPs. In addition, approximately 3% of foreign lawyers (40 out of 1,316) have successfully qualified to practice local Singapore law. 18 of these work at SLPs while 12, 5 and 5 work at FLPs, QFLPs and JLVs, respectively.

Major international law firm operating structures and sizes

From SSQ's latest research, we understand there to be 57 US/UK-headquartered, major international law firms already operating in Singapore. Their Singapore offices vary in size and are made up of various legal structures including SLP, FLP, QFLP, JLV or RO.

The majority of these major US/UK firms (58%, so 33 out of 57) take the structure of FLP in Singapore. FLP is the easiest to set up and provides opportunities for further growth via conversion to more local structures such as QFLP, JLV or FLA. However, under FLP, the practice area is limited to foreign law which may not meet all law firms' business needs, especially for those whose practice often requires local advice. For those firms who focus their business on cross-border matters, happy to just work on offshore law, the FLP structure is more sustainable.

To achieve other more local structures such as QFLP, JLV, FLA or shareholding in an SLP, the foreign law firm (and the local co-operation firm if required by regulations) usually needs to meet some basic threshold requirements including team size, ratio between local and foreign lawyers, history with foreign and local firms. One guiding principle is that the foreign interest should never exceed one third. In addition, the QFLP route has been suspended for a few years by the local authority, and there are no details yet regarding when it will be re-opened for new applications.

26 of these 57 US/UK international law firms in Singapore are large, including 8 FLPs, 8 QFLPs, 5 JLVs and 5 shareholding/partnering in SLPs. This accounts for around 58% of all the large-sized law firms in Singapore (26 out of 45). However, each of the 'Big Four' Singapore firms (namely, Rajah & Tann, Allen & Gledhill, WongPartnership and Drew & Napier) employ 300-400 lawyers which is far more sizable than every large US/UK firm's Singapore presence, whose lawyer headcounts usually stand between 30 and 60. These 'Big Four' Singapore firms together employ more than 1,200 lawyers from a total of around 7,000 in the city-state. Therefore, in terms of size, these foreign firms are dwarfed by the local Singapore players.

In addition, 8 US/UK international law firms have formed FLAs with local SLPs:

The major US/UK international law firms account for approximately 35% of all foreign law firms in Singapore (56 out of 161, excluding the ROs but including the 5 SLPs with foreign shareholding/partnership). The remaining 105 foreign law firms are all FLPs and operate as small/medium sized. Some of them are leading players in their home jurisdictions in Asia and Europe, including Japan, South Korea, China, India, Australia, France and Germany. Major offshore law firms have also set up their branches in Singapore. A non-exhaustive list of these leading brands in Singapore is as follows:
